

Haunted Forest Confirmation Letter to Leaders and Adults

Welcome to Camp Tonkawa. We appreciate your patronage and look forward to providing a safe and rewarding experience for you and your family at the 2021 Texas Trails Council Haunted Forest. In order to best service your stay here I have outlined some policies and procedures to make this Event as simple and ideal as possible barring any unforeseen issues requiring further measures being taken.

First, as we all know if you have been to this event in the past driving on Camp Tonkawa is a big issue. Check-In will Start at 6:00pm Friday October 22nd, 2021, no one will be able to go to their Campsite before that time, unless you have made arrangements with our Camp Ranger. As you Check-In and are allowed to go to your Campsite, you will have only 15 minutes to unload your vehicle. Please do not Park and Start Setting Up your Campsite, Unload your vehicle and drive it to our Northside Parking Lot, we will have Golf Carts to drive you back to your Campsite for Setup. This time frame is to facilitate the ability to get everyone one on camp in a timely manner. If you have forgotten anything in, your vehicle the Golf Cart Drivers will be going around all evening to help you get back and forth from the Parking Lot.

In addition to the parking procedures, we have adopted the policy that NO vehicles may stay at the campsite upon arrival after **DROP OFF** of personal and unit gear at the. (The one Trailer.) The campsite access road is a **5mph One-Way Road** starting at the Dining Facility and looping around to the back of the Campsites as reflected on the attached map. Drop off means, the vehicle may pull up as close as site access roads allow, personal and unit's gear is offloaded, then the vehicle promptly returns to the designated Northside parking areas. This will alleviate issues with multiple vehicles trying to utilize a one lane road; putting our Scouts in danger, as the road also acts as a walking trail to the facilities of the Camp. Please remember the speed limit is **5mph** on the Campsite loop road.

Finally, with all the driving and parking policies taking care of let's move on to items that are Not allowed on Camp Tonkawa. Items to Leave at Home: Tobacco Products of any Kind (Camp Tonkawa is a Tobacco Free Properties, and the use of any Tobacco product is prohibited NO matter what age), Weapons of any Kind, Firearms or Ammunition of any Kind, Sheath Knives with a Blade over 4 ½ inches Long, Controlled Substances of any Kind, Alcohol, Fireworks, Pet of any Kind (The Camp Rangers Dog and Service Dogs with Certifications are the only Pets aloud), and lastly Gas Power Generators of any kind. All the Items listed above are to be left at Home, if you are seen with any of these items you may be asked to leave the camp property.

As always, if there are any special considerations for members of your Unit due to inability to access facilities be it disability, injury, need for electricity for medical equipment, or any other restricting issue, please discuss with Camp Ranger before arriving at Camp Tonkawa, so that we can make appropriate accommodations to facilitate those needs.

If you have any kind of emergency while you are on Camp for the Event, Please Contact our Camp Medic. We understand that your safety is the number one factor, but with the BSA we have Policies and Procedures we need to follow here on Camp. So, any medical needs please go to our Camp Medic or find our Camp Ranger.

Thank you again for signing up to come to the 2021 Texas Trails Council, BSA Cub Scout Haunted Forest here with us at Camp Tonkawa and enjoy the time you have at our Camp as much as we enjoy having you!
